The orders total approximately \$6.4 million and are expected to be delivered in the first half of fiscal 2024.

Rob Capps, MIND's President and Chief Executive Officer, stated, "We are pleased to add these orders to our existing book of business ahead of the end of our fiscal year. These are a further indication of the strength we are seeing within our exploration market. We believe that these orders, when combined with our existing backlog and additional expected orders, will set the stage for a continuation of the growth we have experienced within this market segment."
