On May 8, 2024, MIND Technology, Inc. (the "Company") issued the attached press release regarding the rescheduled meeting of holders of its 9.00% Series A Cumulative Preferred Stock, \$1.00 par value per share (the "preferred stock") and the revision of the proposed amendment to the terms of the preferred stock. The revised amendment provides that at the discretion of its Board of Directors deciding to file the Amendment with the Secretary of State of the State of Delaware at any time prior to July 31, 2024, each share of preferred stock shall be converted into 3.9 shares of common stock, \$0.01 par value per share, upon the effective time of the Amendment (the "Preferred Stock Proposal"). A copy of the press release is furnished as Exhibit 99.1 to this report and incorporated by reference into this Item 8.01.

On May 8, 2024, the Company also made available a new corporate presentation regarding the Preferred Stock Proposal. MIND Technology Announces New Date For Virtual Special Meeting of Preferred Stockholders and Revised Proposal

THE WOODLANDS, TX, May 8, 2024 – MIND Technology, Inc. ("MIND" or the "Company") (Nasdaq: MIND; MINDP) announced today that the previously announced virtual special meeting of holders of its 9% Series A Cumulative Preferred Stock (the "preferred stock") to approve an amendment to the Certificate of Designations, Preferences and Rights of the Preferred Stock has been rescheduled for June 13, 2024. Additionally, the proposed amendment has been revised such that each share of preferred stock would be converted into 3.9 shares of common stock, \$0.01 par value per share (the "common stock"), rather than the 2.7 shares initially proposed, at the sole discretion of the Company's Board of Directors at any time prior to July 31, 2024 (the "revised proposal"). A new record date has also been established.

Preferred stockholders as of the new record date of April 26, 2024 are entitled to vote at a virtual Special Meeting of Preferred Stockholders to be held June 13, 2024. The affirmative vote of two thirds (66 2/3%) of the outstanding shares of preferred stock is required for approval of the revised proposal. Holders of the Company's common stock are not entitled to vote at this meeting. Due to the new meeting date, it was necessary to establish a new record date and solicit new proxies, which process has begun. Proxies from the postponed meeting, including those previously voted, are no longer valid.

Rob Capps, President and CEO of MIND, stated, "Based on feedback from preferred stockholders during the initial solicitation, we determined that it would be appropriate to postpone the special meeting and reconsider the terms of the preferred stock proposal. Due to the diverse holdings of the preferred stock, additional time was necessary to solicit proxies. Additionally, certain preferred stockholders indicated they wanted to see the Company's financial results for the fourth quarter and fiscal year ended January 31, 2024 before casting a vote on the proposal. We filed our annual report on Form 10-K for fiscal 2024 on April 30, 2024. Finally, certain preferred stockholders indicated an unwillingness to support the proposal at the conversion rate initially proposed, but would consider supporting a revised conversion rate. Based on discussions with these holders, we believe they will be supportive of the revised proposal.

"We believe the revised proposal is in the best interests of all stakeholders in MIND as it provides financial flexibility and simplifies our capital structure. It, in my opinion, provides the best opportunity to take advantage of our improving operations and create additional value for all stockholders. The continued accrual of preferred stock dividends creates what I believe is an "overhang" which limits our ability to obtain growth capital and makes us less attractive to potential partners.

"Based on the 10-day volume weighted average price of the preferred stock and common stock as of March 3, 2024, the revised proposal provides preferred stockholders with common stock valued at \$19.66 per share, which is approximately a 112% premium to the market value of the preferred stock, with the potential to participate in the Company's further growth. Following the conversion, current preferred stockholders will hold approximately 82% of the Company's common stock which effectively expands the current voting rights of the preferred stockholders," concluded Capps.

Explanation of Postponement

- The postponement of the meeting was deemed necessary for the following reasons:
 - More time was required to solicit sufficient proxies
 - Some preferred stockholders wanted to review Fourth Quarter Fiscal 2024 results before voting – we announced those results on April 29, 2024
 - Some preferred stockholders were not supportive of the initial proposal, but indicated support at a revised exchange ratio
- The new meeting date (June 13, 2024) necessitated a new record date (April 26, 2024)
- Therefore, proxies from the postponed meeting, including those previously voted, are no longer valid



What is the Revised Proposal

- Amend the terms of the Series A Preferred Stock
 - Amendment to Certificate of Designations, Preferences and Rights of MIND Technology, Inc. 9.00% Series A Cumulative Preferred Stock (the "Series A Preferred Stock")
- Provides for the conversion each share of Series A Preferred Stock into 3.9 shares of MIND common stock at the discretion of the Company's Board of Directors at anytime prior to July 31, 2024



Benefits to Preferred Stockholders

- Estimated market value of common received represents a significant premium to the market value of the preferred stock
- · Benefit from any accretion in value of common stock
- Larger combined market for the common stock
- · Facilitates the Company's growth
- Makes the Company a more attractive acquisition target
- Increase in Company's value accrues predominately to preferred stockholders due to majority ownership
- · Expanded voting rights






Illustration of Proposal

- Market prices
 - Preferred Stock \$9.29 / share 1
 - Common Stock \$5.04 / share ¹
- Value received upon conversion 3.9 shares of common X \$5.04 / share
 = \$19.66 / share of preferred stock
 - Approximately a 112% premium to the market value of the preferred stock
- Upon conversion current holders of preferred stock would own approximately 82% of all common stock

Reasons for Proposal

- The Company's current operations and expected cash flow don't support the payment of preferred stock dividends and at the same time fund anticipated growth
- Management believes the existence of the preferred stock creates an "overhang" which limits the Company's flexibility and options
 - · Limits access to additional capital
 - Inhibits merger and acquisition opportunities
 - · Inhibits growth opportunities



Risks to Preferred Stockholders

- Forfeit rights to accumulated and any future dividends
- Forfeits liquidation preference
- Current market value of common stock received is less than liquidation preference of preferred stock
- Future market value of common stock is uncertain
- Anticipated growth in business may not occur



- The terms of the Series A Preferred Stock will not be amended
 - Accumulated and unpaid dividends will not be eliminated
 - · Further dividends will continue to accumulate
 - Dividends will be paid when, as and if declared by the Board of Directors
- · We will consider other restructuring options, such as
 - An exchange offer with different terms from the Proposal
 - Issuing debt instruments, which could include conversion features and with seniority to the Series A Preferred Stock
 - · Entering into other debt obligations, such as secured credit facilities



Required Approvals

- The amendment must be approved by 2/3 of the outstanding preferred stock
 - Non-votes are effectively a "no" vote
- Holders of MIND common stock are not entitled to vote on this matter
